## ORDER SETTING EVIDENTIARY HEARING AND DIRECTING PARTIES TO FILE JOINT PROPOSED PROCEDURAL SCHEDULE

On January 30, 2015, Laclede Gas Company ("Laclede") filed an application and petition with the Commission requesting authority to change its Infrastructure System Replacement Surcharge ("ISRS") for its Laclede Gas Service Territory. The Commission issued notice of the application and received no intervention requests. On March 19, 2015 the Office of Public Counsel filed a motion requesting that the Commission reject or deny the application or set the matter for an evidentiary hearing. The Commission will schedule an evidentiary hearing. Section 393.1015.2(3), RSMo (Cum.Supp. 2013), requires the Commission issue an order on Laclede's application that is effective no later than May 30, 2015. In light of this statutory deadline and constraints in the Commisson's schedule, the evidentiary hearing will be scheduled for April 20, 2015. Recognizing the difficulties this accelerated hearing date may cause for the parties, the Commission requests their input on a proposed procedural schedule that identifies deadlines for: the end of discovery, prefiled testimony; issues list, witness list, position statements, and one round of post-hearing briefs.

## THE COMMISSION ORDERS THAT:

- An evidentiary hearing is scheduled for April 20, 2015, beginning at 9:00 a.m.
   The hearing will be held in Room 310 of the Governor Office Building, 200 Madison Street,
   Jefferson City, Missouri.
- 2. The hearing will be held in a building that meets accessibility standards required by the Americans with Disabilities Act. - 3. The parties shall file a joint proposed procedural schedule no later than March 27, 2015.
