STAFF RECOMMENDATION ON COMPLIANCE TARIFF FILING

COMES NOW the Staff of the Missouri Public Service Commission and pursuant to the Commission's April 28, 2017 *Order Directing Filing* submits its *Staff Recommendation on Compliance Tariff Filing* to the Commission as set forth in the attached memorandum, and in support states as follows:

1. On April 26, 2017, the Commission issued an Order Approving Unanimous Stipulation and Agreement which authorized Laclede Gas Company ("Laclede") to file a tariff sheet with an ISRS rate for each customer class as reflected in Appendix B of the Staff Recommendation filed on April 4, 2017.

2. On April 27, 2017, Laclede filed a tariff sheet intended to comply with the Commission's April 26th order, which tariff sheet bears a proposed effective date of June 1, 2017. This tariff filing was designated as Tariff Tracking No. YG-2017-0219.

3. On April 28, 2017, the Commission issued an *Order Directing Filing* which ordered Staff to file a response to the proposed tariff no later than May 9, 2017, indicating if the tariff is in compliance with the unanimous agreement of the parties¹ and whether Staff recommends approval of the tariff sheet.

¹ Staff interprets "the unanimous agreement of the parties" to refer to the Unanimous Stipulation and Agreement filed herein on April 18, 2017.

4. Staff's recommendation is attached hereto and is incorporated herein by reference. As reflected in the attached, Staff has reviewed the tariff sheet filed by Laclede on April 27, 2017, and has determined that the rates therein comply with those authorized by the Commission and that the tariff sheet is in compliance with the unanimous agreement of the parties.

5. Staff has verified that Laclede has filed its annual report and is not delinquent on any assessment. Staff is not aware of any other matter before the Commission that affects, or is affected by this filing, other than Laclede's previous ISRS cases which are on appeal.

WHEREFORE, Staff recommends that the Commission issue an order in this case that approves the following tariff sheet (Tariff Tracking No. YG-2017-0219) as filed on April 27, 2017, to go into effect on June 1, 2017, as requested by Laclede:

On April 26, 2017, the Missouri Public Service Commission ("Commission") issued its ORDER APPROVING UNANIMOUS STIPULATION AND AGREEMENT which authorized Laclede Gas Company (Laclede or Company) to file tariff sheets with an ISRS rate for each customer class as reflected in Appendix B of the Staff Recommendation filed on April 4, 2017, in Case No. GO-2017-0202.

On April 27th, the Company filed a tariff sheet intended to comply with the Commission's April 26th Order.

On April 28th the Commission issued an ORDER DIRECTING FILING, requiring the Staff to file a response to the proposed tariff no later than May 9, 2017, indicating if these tariffs are filed in compliance with the unanimous agreement of the parties and whether Staff recommends approval of the revised tariff sheets.

The tariff sheet has a proposed effective date of June 1, 2017.

Staff has reviewed Laclede's tariff sheet and has determined that Laclede's submitted ISRS tariff sheet (YG-2017-0219) complies with those prescribed rates authorized by the Commission's Order. The Staff further states the tariff is filed in compliance with the unanimous agreement of the parties and the Staff recommends approval of the revised tariff sheet.

Based upon the Commission's April 26, 2017, ORDER APPROVING UNANIMOUS STIPULATION AND AGREEMENT, Staff is recommending that Laclede receive incremental
