ORDER DIRECTING RESPONSE

The Commission opened this file at the request of its Staff to facilitate Staff's investigation into Laclede Gas Company's compliance with the gas supply documentation requirements of its Cost Allocation Manual (CAM) and its Gas Supply and Transportation Standards of Conduct (SOC). Staff filed its report regarding that investigation on August 22, 2017, finding that Spire failed to comply with certain aspects of its CAM and SOC. Staff asked Spire to bring itself into full compliance by December 31, 2017. Spire Missouri Inc., f/k/a Laclede responded on October 16, indicating it would comply with most of Staff's recommendations.

The Commission will direct Staff to explain whether it is satisfied with Spire's compliance and whether this file needs to remain open.

THE COMMISSION ORDERS THAT:

1. No later than January 16, 2018, Staff shall indicate whether it is satisfied with Spire Missouri's Inc.'s compliance with the gas supply documentation requirements of its Cost Allocation Manual and its Gas Supply and Transportation Standards of Conduct. Staff shall also indicate whether it believes this file should remain open.

2. This order shall be effective when issued.
