On April 30, 2018, Spire Missouri Inc., (“Spire”) filed pleadings requesting a waiver of the Commission’s 60-day notice of intended case filings rule.¹ Spire states that the Commission has good cause to waive that rule because Spire has not communicated with the Commission within the prior 150 days about this Infrastructure System Replacement Surcharge request.

On May 14, 2018, the Office of the Public Counsel (“OPC”) filed an objection. The Commission will order its Staff, and allow Spire, to respond to OPC’s objection.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall, and Spire may, respond no later than May 21, 2018.
