

**AMENDMENT TO APPLICATION FOR CERTIFICATE OF SERVICE AUTHORITY  
AND FOR COMPETITIVE CLASSIFICATION**

CAT Communications International, Inc. filed an Application with the Missouri Public Service Commission (Commission) on December 8, 1999 for a certificate of service authority to provide resold interexchange and basic local telecommunications service in Missouri and for competitive classification.

On December 14, 1999, the Commission issued a Notice of Deficiency requesting (1) that the Company clarify whether the company or its services should be classified as competitive; and (2) submit a statement of the character of the business performed by the Company.

In response to the Notice of Deficiency, the Company hereby requests that its application be amended to include the following statements:

- (1) The Company requests classification as a competitive telecommunications company, and requests that all references to requests for competitive classification of its services be omitted from its application.

- (2) The character of the business performed by the Company is that of a telecommunications provider offering resold local exchange and interexchange service in approximately nine states.

WHEREFORE, CAT Communications International, Inc. hereby requests that the Commission proceed with its Application, as amended, and grant the requested authority to provide interexchange and local exchange telecommunications services, grant all waivers requested, and classify the Company as a competitive telecommunications company.
