The Commission directed its Staff (Staff) to file a recommendation or status report about Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty (Liberty Midstates) application to issue long-term unsecured debt. On March 27, 2023, Staff filed a motion requesting a 30 day extension to file its recommendation. Staff's motion represents that no party objects to the extension. The Commission will grant Staff's motion and set a time for responses.

THE COMMISSION ORDERS THAT:

1. Staff's motion for an extension is granted. Staff shall file its recommendation in this matter no later than April 26, 2023.
2. Any responses to Staff's recommendation or Liberty Midstates' application shall be filed no later than May 5, 2023.
