**ORDER SHORTENING TIME TO RESPOND TO DATA REQUESTS AND
DIRECTING STAFF TO FILE A FURTHER REPORT**

The Commission opened this file to facilitate Staff's investigation into recent interruptions in Summit Natural Gas of Missouri Inc.'s deliveries of natural gas to its Rogersville service division, including the Lebanon, Missouri area. As directed, Staff filed a progress report regarding its investigation on January 25, 2018.

Staff reports it has commenced its investigation but will need more time to gather information from Summit. To that end, Staff asks the Commission to allow Staff until February 28 to file an additional report. Staff also asks that Summit be directed to respond to Staff's data requests on an expedited schedule.

The Commission will grant Staff's requests.

IT IS ORDERED THAT:

1. Staff shall file a further status report regarding its investigation no later than February 28, 2018.

2. Summit Natural Gas of Missouri Inc. shall respond to Staff's data requests regarding this investigation by providing answers to those requests within ten days and any objection to those requests within five days after receiving the data request.

3. This order shall be effective when issued.
