**STAFF’S RECOMMENDATION TO APPROVE TARIFF FILING**

**COMES NOW** the Staff of the Public Service Commission of the State of Missouri (“Staff”), by and through counsel, and pursuant to the Commission’s July 25, 2019 *Order Establishing Time for Staff to File a Recommendation* submits its *Staff’s Recommendation to Approve Tariff Filing* in support states as follows:

1. On June 5, 2019, Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri”) filed a request for a variance from Commission rule 4 CSR 240-13.020(6) to allow customers to choose a due date. Ameren Missouri filed a tariff on the same day to implement the variance request.

2. On June 24, 2019, the Commission in its *Order Granting Variance and Rejecting Tariff* (“Order”) granted Ameren Missouri’s request for variance from Commission rule 4 CSR 240-13.020(6) and rejected the tariff filed June 5, 2019.

3. On July 25, 2019, Ameren Missouri filed tariff sheets intended to comply with the Commission’s June 24, 2019 *Order*. The tariff filing was assigned Tariff Tracking No. YG-2020-0015 and would be effective August 24, 2019.

4. Also on July 25, 2019, the Commission issued its *Order Establishing Time for Staff to File a Recommendation* ordering Staff to file a recommendation no later than August 8, 2019, regarding Ameren Missouri’s tariff.

5. Staff has reviewed the tariff sheets filed by Ameren Missouri and has determined that the tariff sheets are in compliance with the Commission's June 24, 2019 Order. Thus, Staff recommends approval of:
