On June 20, 2018, Spire Missouri Inc. filed a verified application for approval of financing authority. Spire requests financing authority in the amount of \$500 million through September 30, 2021, subject to the same terms and conditions approved by the Commission in File No. GF-2015-0181. Additionally, Spire requested that the Commission approve the financing no later than September 30, 2018, the expiration of its current financing authority. Because of the request for expeditious approval, Spire requested that the Commission order an early procedural conference so that the parties can discuss the anticipated timeline for processing this case.

The Commission will order its Staff to file a recommendation or, in the alternative, a status report stating when Staff plans to file its recommendation. Additionally, the Commission will set an early procedural conference.

THE COMMISSION ORDERS THAT:

1. The Staff of the Missouri Public Service Commission shall file its recommendation or a status report stating when it plans to file its recommendation no later than July 20, 2018.

- 2. The parties shall appear at a procedural conference to be held on July 11, 2018 at 1:00 p.m.
- 3. The procedural conference will convene in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri 65102. The building meets accessibility standards required by the Americans with Disabilities Act.
