## ORDER DIRECTING RESPONSES TO CONDITIONS PROPOSED BY OPC

On December 22, 2021, Spire Missouri Inc. d/b/a Spire submitted an application requesting financing authorization in the amount of \$800 million through December 2024, subject to all of the terms and conditions approved by the Commission in File No. GF-2020-0334.

On February 10, 2022, the Office of the Public Counsel (OPC) filed a timely response to Staff's recommendation. OPC has suggested an additional three conditions or modifications to Staff's suggested conditions.

The Commission will direct Spire to file a response to OPC's filing.

### **THE COMMISSION ORDERS THAT:**

1. Spire shall file a response to OPC's recommendations on or before February 17, 2022.
2. Other parties are permitted, but not required, to also reply to OPC's recommendations. Those responses are due on or before February 17, 2022.
2. This order shall be effective when issued.
