On April 21, 2022, the Commission granted SNGMO's request for its parent company, Summit LDC Holdings, LLC to issue indebtedness secured by a pledge of SNGMO's capital stock. On August 15, 2022, SNGMO filed a *Status Report Concerning Timing of Transaction*, informing the Commission that credit rollover maturity date was extended to October 31, 2022, and that SNGMO would timely file the terms of any debt when issued. The Commission will order the SNGMO to file status report.

THE COMMISSION ORDERS THAT:

1. SNGMO shall file a status report informing the Commission of the status of this financing transaction no later than February 15, 2023.
2. This order is effective when issued.
