STAFF'S RECOMMENDATION TO APPROVE TARIFF SHEET

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and, for its recommendation to approve tariff sheet, respectfully states:

1. In the attached Memorandum (Appendix A) the Staff recommends the Missouri Public Service Commission (Commission) approve the tariff sheet KCP&L Greater Missouri Operations Company (GMO) filed on April 15, 2009, and substituted on May 07, 2009, to become effective June 1, 2009. GMO filed the tariff sheet to make a quarterly cost adjustment required as part of the Stipulation and Agreement approved by the Commission in Case No. HR-2005-0450. That Stipulation and Agreement includes a “fuel rider” that requires quarterly rate adjustments, with not more frequent than annual true-ups.

2. Staff has reviewed the tariff sheet and is of the opinion that the quarterly cost adjustment for the 2009 Q1 has been calculated in accordance with the provisions of the Quarterly Cost Adjustment Rider tariff sheet and complies with the Commission’s Order in HR-2005-0450.

3. The Staff recommends the Commission issue an order approving the proposed tariff sheet to be effective June 1, 2009, or allow the sheet to go into effect by operation of law.

WHEREFORE, the Staff of the Missouri Public Service Commission recommends the Commission either approve to become effective June 1, 2009 or allow to go into effect by

operation of law on June 1, 2009, the Tariff Sheet GMO filed on January 15, 2009, and substituted on May 07, 2009, to wit:
