ORDER GRANTING VARIANCE

Laclede Gas Company's Cost Allocation Manual (CAM) and prior orders from this Commission require Laclede to maintain affiliate transaction information on a fiscal year basis (12 months ended on September 30) and to provide an annual CAM filing to the Commission on December 15 of each year. On December 14, 2016, Laclede filed an application for variance requesting that it be allowed an additional five business days, until December 22, to make its annual CAM filing. The motion represents that the Commission's Staff does not object to the request for additional time.

The Commission will grant Laclede the additional time it seeks.

THE COMMISSION ORDERS THAT:

1. Laclede Gas Company's application for variance is granted and it shall file its annual CAM filing for Fiscal Year 2016 by December 22, 2016.
2. This order shall be effective when issued.
