**ORDER DIRECTING STAFF TO FILE A RECOMMENDATION**

On December 1, 2016, Union Electric Company d/b/a Ameren Missouri filed an application requesting a modification of its existing variance from the Commission’s rule that establishes gas meter testing procedures. Ameren Missouri ask that the Commission approve that modification in time to allow the revised procedures to go into effect on January 1, 2017.

The Commission will direct its Staff to file a recommendation regarding the variance request. Because Ameren Missouri has requested expedited consideration, the Commission will direct Staff to respond quickly. However, if Staff, or any other party, believes that more time is needed to thoroughly examine Ameren Missouri’s request for variance they may request additional time to respond.

**THE COMMISSION ORDERS THAT:**

1. The Staff of the Missouri Public Service Commission shall file a recommendation regarding Union Electric Company d/b/a Ameren Missouri’s request for variance no later than December 16, 2016.

2. This order shall be effective when issued.
