On September 23, 2022, Spire Missouri, Inc. d/b/a Spire filed the above-referenced request. The Commission ordered its Staff to file a Recommendation no later than October 26, 2022. Upon Staff’s motions, the Commission extended Staff’s deadline to January 30, 2023, and to April 5, 2023.

On April 3, 2023, Staff filed a Status Report and Second Motion for Extension. In that report, Staff stated that it had outstanding data requests, and that it believes it can complete discovery and provide a Recommendation no later than May 26, 2023. Thus, Staff asks for an extension of time until May 26, 2023 to file a Recommendation.

The Commission finds Staff’s request reasonable, and it will grant it.

1. The Third Motion for Extension is granted.
2. The Staff of the Commission shall file a Recommendation no later than May 26, 2023.
3. This order shall be effective when issued.
