ORDER APPROVING PACC FILING

Issue Date: March 21, 2018 Effective Date: March 31, 2018

On February 1, 2018, Veolia Energy Kansas City, Inc. ("Veolia") filed tariff sheets (Tracking No. JH-2018-0100) to revise its Production Adjustment Cost Clause ("PACC") rates for steam service. The tariff sheets have a proposed effective date of April 1, 2018. The Commission issued an order directing notice be provided of Veolia's filing and set a deadline for applications to intervene. No applications to intervene were received.

On March 1, 2018, the Commission's Staff filed a recommendation on Veolia's PACC tariff sheets. Veolia currently has forty-eight steam customers. Consistent with the terms of the Commission-approved Non-Unanimous Stipulation and Agreement in File No. HR-2014-0066, Veolia submits an annual filing to adjust customer rates to recognize changes in Veolia's PACC production costs experienced during an accumulation period. For this filing, the accumulation period is from January 2017 through December 2017. The PACC customer rates will decrease \$0.16412 per thousand pounds of steam (Mlb). In filed testimony, Veolia witness Matthew

DiGeronimo states the decrease is primarily driven by decreases in the cost of fuel and continued implementation of system efficiencies.¹

Staff evaluated the data and mathematical calculations provided by Veolia in its worksheets and found the calculations to be consistent with Veolia's proposed tariff sheets and the company's tariff for determining PACC. Staff recommended the Commission approve the PACC tariff sheets. No responses to Staff's recommendation were received.

Since no party objected to Veolia's revision of its PACC rates and since the tariff sheets bear an April 1, 2018 effective date, the Commission finds good cause exists to allow this order to go into effect in less than thirty days.

THE COMMISSION ORDERS THAT:

Veolia Energy Kansas City, Inc.'s tariff sheets, assigned Tracking No. 1. JH-2018-0100, are approved to go into effect on April 1, 2018. The specific tariff sheets approved are the following:
