On February 3, 2017, Missouri Gas Energy, an operating unit of Laclede Gas Company (MGE) and Laclede Gas Company (Laclede) each filed verified applications and petitions to change their infrastructure system replacement surcharges (ISRS) and proposed tariff sheets to implement those changes. Additionally, MGE and Laclede filed motions asking the Commission to direct the Office of the Public Counsel (Public Counsel) to file its recommendations regarding the ISRS filing within 60 days and to direct MGE and Laclede to provide their updated information to the Public Counsel at the same time it provides that information to the Staff of the Missouri Public Service Commission. The Commission will set a time for responses to the motion. Because of the expedited nature of an ISRS proceeding, the Commission will require responses on an expedited basis.

- 1. Responses to the motions to require the Office of the Public Counsel to raise any issues in this matter within 60 days of the ISRS filings shall be filed no later than February 9, 2017.
