ORDER SUSPENDING TARIFFS

On June 7, 2018, Spire Missouri Inc., (“Spire”) filed applications and petitions with the Missouri Public Service Commission pursuant to Sections 393.1009, 393.1012, and 393.1015, RSMo. 2016, and Commission Rules 4 CSR 240-2.060 and 3.265, requesting that the Commission authorize it to change its Infrastructure System Replacement Surcharges (“ISRS”). Contemporaneously therewith, Spire filed tariffs bearing effective dates of July 7, 2018 that are designed to implement its ISRS.

Section 393.1015 requires the Commission to act on Spire’s application no later than 120 days after it is filed. That same section also allows the Commission’s Staff to submit a report regarding the ISRS application no later than 60 days after it is filed. The Commission has already ordered its Staff to file such a report.

Because the tariffs’ effective dates do not allow the Commission and its Staff sufficient time to review the applications, the Commission will suspend the tariffs. Because the Commission must rule on the applications no later than October 5, 2018, the Commission will suspend the tariffs until that date.

THE COMMISSION ORDERS THAT:

1. The tariff sheets assigned Tracking Nos. YG-2018-0163 and YG-2018-0164 are suspended until October 5, 2018.
2. This order shall be effective when issued.
