**NOTICE REGARDING TARIFF SHEETS FILED  
IN VERIFIED APPLICATIONS OF SPIRE EAST AND SPIRE WEST**

**COMES NOW** the Staff of the Missouri Public Service Commission, by and through counsel, and for its *Notice Regarding Tariff Sheets Filed in Verified Applications of Spire East and Spire West*, states as follows:

1. On July 15, 2019, Spire Missouri Inc. filed its *Verified Application And Petition Of Spire Missouri Inc. To Change Its Infrastructure System Replacement Surcharge For Its Spire Missouri East Service Territory* and its *Verified Application And Petition Of Spire Missouri Inc. To Change Its Infrastructure System Replacement Surcharge For Its Spire Missouri West Service Territory* (Spire East Application and Spire West Application) in case docket no.'s GO-2019-0356 and GO-2019-0357, respectively.

2. On July 25, 2019, the Commission issued its *Order Suspending Tariff Sheets* (Order) in Case No. GO-2019-0356 for tariff Tracking No. YG-2020-0009 and in Case No. GO-2019-0357 for tariff Tracking No. YG-2020-0010. Spire Missouri Inc. had filed revised tariffs on July 18, 2019 that bear tariff Tracking No.'s YG-2020-0009 and YG-2020-0010 for the purpose of clarifying to the Commission which tariff sheets

Spire Missouri, Inc. intended to take effect. In its July 25<sup>th</sup> Order, the Commission suspended the tariff sheets for both dockets and tariff tracking no.'s until November 12, 2019.

3. However, in an abundance of caution, Staff points out four tariff sheets contained in the applications for which no direct action has been taken. The Spire East Application contains two tariff sheets issued by Scott Weitzel on July 15, 2019, with an effective date of August 14, 2019 (see attachments herein; also see p.65 of 200 and p. 197 of 200 of the Spire East Application). The Spire West Application contains two tariff sheets issued by Scott Weitzel on July 15, 2019, with an effective date of August 14, 2019 (see attachments herein; also see p. 63 of 169 and p.166 of 169).

4. To avoid the possibility of confusion, Staff gives notice that it understands that the tariff sheets referenced above and contained in the verified applications serve as specimen tariff sheets for exemplar purposes only.

**WHEREFORE**, Staff prays the Commission accept its *Notice* and issue any other orders as may be just in the circumstance.
