JOINT MOTION TO SUSPEND PROCEDURAL SCHEDULE

COMES NOW, Spire Missouri Inc. (“Spire” or “the Company”), on behalf of its operating units Spire Missouri East and Spire Missouri West, the Staff of the Missouri Public Service Commission (“Staff”) and the Office of the Public Counsel (“OPC”) submit this Joint Motion to Suspend Procedural Schedule, and in support thereof, states as follows:

1. The procedural schedule issued by the Commission in this case provided for testimony to be filed on April 17, 2020, an issues list to be filed on April 21, and statement of positions due on April 22. The hearing in these cases are scheduled for April 27-28, 2020.

2. Spire, OPC and Staff (collectively referred to as “the Parties”) have reached a unanimous stipulation and agreement resolving all issues in these cases. A copy of the unanimous stipulation and agreement is to be filed contemporaneously with this motion.

3. The Parties agree that the procedural schedule should be suspended pending approval by the Commission of the Parties’ Unanimous Stipulation and Agreement.

WHEREFORE, the Parties respectfully requests that the Commission suspend the procedural schedule.
