## ORDER GRANTING EXTENSION

On December 23, 2021, Spire Missouri Inc., filed an application requesting that the Commission authorize changes to the Spire Missouri East and Spire Missouri West Infrastructure System Replacement Surcharges (ISRS). The Staff of the Commission (Staff) filed its recommendation regarding the application on March 23, 2022. The Commission has previously ordered responses to Staff's recommendation be filed no later than March 30, 2022.

On March 29, 2022, Spire Missouri filed a request for additional time. The request is represented to be unopposed by counsel for Staff and the Office of the Public Counsel. Based on that representation, the Commission will consider the request unopposed. The request is made for additional time as the parties believe they can reach an agreement on a resolution for the case.

The Commission finds the unopposed extension request reasonable and will grant it.

### THE COMMISSION ORDERS THAT:

1. Spire Missouri's request for additional time is granted.
2. No later than April 7, 2022, Spire Missouri shall respond to Staff's recommendation.

3. Any other party wishing to respond or object to Staff's recommendation shall do so no later than April 7, 2022.

4. This order shall be effective when issued.
