ORDER ESTABLISHING ENDING ACA BALANCES

Issue Date: February 15, 2012

Effective Date: February 25, 2012

On December 21, 2011, the Staff of the Commission filed its 2009-2010 Actual Cost Adjustment ("ACA") Recommendation. On January 4, 2012, the Commission ordered Atmos Energy Corporation ("Atmos") to respond to Staff's Recommendation. Atmos did so on January 23, 2012.

Staff responded to Atmos on February 3, 2012. Staff states that Atmos commented on two issues: (1) Supply for Combined Hannibal, Canton, Palmyra and Bowling Green Service Areas, and (2) Storage Balance for Piedmont/Arcadia (MRT system). There were no recommended financial adjustments for these issues, and neither Atmos nor Staff asks the Commission to take action on these issues.

Staff filed a revised ACA table for the 2009-2010 ACA Recommendation. According to Staff, Atmos concurs with Staff's revised recommendation. Thus, the Commission accepts the ending balances recommended by Staff. Since no party has opposed this result, regulatory efficiency will be served if this order takes effect promptly. The Commission will make this order effective in ten days.

THE COMMISSION ORDERS THAT:

1. The ending (over)/under recovery balances for Atmos Energy Corporation's 2009-2010 Actual Cost Adjustment are established as provided in the following table:
