On October 25, 2016, Laclede Gas Company filed a tariff in this file that would make a temporary modification to its Low-Income Energy Affordability Program. Laclede asks that this revised tariff be allowed to go into effect on November 4, 2016. Laclede filed its tariff and motion for expedited treatment in this closed rate case, causing the file to reopen in EFIS. Rather than consider this new tariff filing in the old case, the Commission has assigned the tariff filing to a new file, File No. GT-2017-0123. The tariff will be considered in that file, and this file shall be reclosed.
