REQUEST FOR EXTENSION IN FILING DATES

COMES NOW Missouri Gas Energy, a division of Laclede Gas Company for its Request for an Extension in Filing Dates, states as follows:

- 1. On September 16, 2013, Missouri Gas Energy, a division of Laclede Gas Company ("MGE" or "Company") submitted to the Missouri Public Service Commission ("Commission") revised tariff sheets reflecting increased rates for gas service provided to customers in its Missouri service area.
- 2. By Order dated November 13, 2013, the Commission adopted the Parties' recommended procedural schedule.
- 3. By order dated February 28, 2014, the Commission approved an extension of filing dates whereby the filing date for surrebuttal testimony be extended from Friday, March 28 to Tuesday, April 1, 2014.
- 4. In recent weeks, the parties have met on a number of occasions in an effort to potentially narrow their differences and are still actively engaged in settlement negotiations. The parties believe that a short extension of time to file surrebuttal testimony is warranted in order to permit the continued exploration of full or partial settlement of the issues.

5. For these reasons, MGE respectfully requests that the filing date for surrebuttal testimony be extended for two days to Thursday, April 3rd, 2014. MGE would also request to move the following dates:

Close of Discovery: change from April 7, 2014 to April 9, 2014

List of Issues, Order of Witnesses, Order of Cross-Examination,

Order of Opening: change from April 7, 2014 to April 9, 2014

Reconciliation: change from April 9, 2014 to April 10, 2014

6. MGE has discussed this request with the other parties to this case, and counsel for those parties have indicated that they have no objection to this request.

WHEREFORE, for the foregoing reasons, MGE respectfully requests that the Commission issue its Order revising the procedural schedule as requested herein.
