STAFF STATEMENT DESCRIBING DISCOVERY CONCERN

COMES NOW the Staff (Staff) of the Missouri Public Service Commission

(Commission), by and through counsel, and respectfully submits the following statement

of discovery concerns pursuant to Section 6(B) of the Procedural Schedule in this case:

1. On February 26, 2014, the Commission issued its Order Setting Procedural Schedule and Terms of Discovery, which adopted the Joint Proposed Procedural Schedule and Discovery Order.

2. Paragraph 6(B) of the *Procedural Schedule* provides:

Not less than two (2) business days before each discovery conference, any party that has a discovery disagreement or concern involving another party shall file a brief statement describing that disagreement or concern and identifying any other parties involved. Such statement does not need to be a formal motion to compel.

3. The next such discovery conference in this matter is scheduled for Tuesday, July 15, 2014.

4. On June 19¹, the Commission granted Staff's Motion to Compel certain financial data related to SNG's parent company and the parent company's sole shareholder. On June 25, the Commission extended SNG's time to provide the data to July 2. On July 7, the Commission denied SNG's motion for reconsideration of the order granting the motion to compel.

5. As of the date of this filing, Staff has not received the data from SNG that the Commission ordered SNG to produce.

6. Staff has been in discussions with SNG about provision of the data. Therefore Staff requests that the Commission convene the discovery conference as scheduled on Wednesday, July 15, in order to discuss with SNG and the Commission a timetable for SNG to provide this data.

7. Further, the discovery conference will be an opportunity for Staff to discuss SNG's June 16 objection letter related to Staff's data request 0217.²

WHEREFORE, Staff respectfully requests the Commission issue an order convening the discovery conference scheduled in this matter for 10 a.m. on Tuesday, July 15, 2014.
