**AMEREN MISSOURI'S NOTICE OF VERIFICATION OF
PRE-QUALIFICATION PROCESS IN PLACE FOR CONTRACTORS SEEKING TO
PARTICIPATE IN A COMPETITIVE BIDDING TO INSTALL
ISRS-ELIGIBLE GAS UTILITY PLANT PROJECTS**

COMES NOW Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri” or “Company”), and pursuant to Section 393.1012.4, RSMo., files this Notice of Verification of Pre-Qualification Process in Place for Contractors Seeking to Participate in a Competitive Bidding to Install ISRS-Eligible Gas Utility Plant Projects. In support hereof, the Company respectfully states as follows:

1. The Company is a Missouri corporation doing business under the fictitious name of Ameren Missouri, in good standing in all respects, with its principal office and place of business located at 1901 Chouteau Ave., St. Louis, Missouri 63103. Ameren Missouri is engaged in providing gas utility services in portions of Missouri as a public utility under the jurisdiction of the Commission. The contact information for Ameren Missouri's counsel is set forth below.

2. Amendments to the Infrastructure System Replacement Surcharge ("ISRS") statutes (Sections 393.1009 *et seq.*, RSMo.) became effective August 28, 2020. The amendments included an addition to Section 393.1012.4, RSMo. that requires gas corporations to develop and file with the Commission a pre-qualification process for contractors seeking to participate in competitive bidding to install ISRS-eligible gas utility plant.

3. Pursuant to Section 393.1012.4, RSMo., on June 30, 2021, Ameren Missouri filed with the Commission its Pre-Qualification Process and Pre-Qualification Requirements.

4. Also pursuant to Section 393.1012.4, RSMo., the Company now files a Verification from Pamela Harrison, Director of Missouri Gas Operations, confirming that the pre-qualification process for ISRS contractors is in place.

5. Communications, correspondence, orders, and decision in this matter should be addressed to the undersigned counsel for the Company.

WHEREFORE, Ameren Missouri respectfully requests that the Commission accept this Notice, and for any other relief the Commission deems appropriate.
