**NOTICE OF CORRECTION TO STAFF RECOMMENDATION**

**COMES NOW** the Staff of the Missouri Public Service Commission, by and through counsel, and for its notice of correction to Staff's recommendation in this matter hereby states:

1. On February 21, 2014, Union Electric Company d/b/a Ameren Missouri filed revised tariff sheets to increase its Purchased Gas Adjustment (PGA) rate.
2. The tariff sheets (JG-2014-0328) bear a proposed effective date of March 7, 2014.
3. On February 25, 2014, the Commission ordered Staff to file its recommendation regarding the proposed tariff sheets on an expedited basis no later than February 27, 2014. Staff filed its recommendation in compliance with Commission order.
4. After Staff filed the recommendation on February 27, Staff discovered a numerical error in the recommendation *Memorandum*.
5. In Staff's *Memorandum* Paragraph 2, which describes changes in the purchased gas adjustment (PGA) rate for all Ameren Missouri's natural gas service areas other than the Rolla Service Area, the final sentence states that "[t]hese changes represent an increase of \$0.1200 per Ccf."

6. In fact, the changes to the PGA rate for Ameren Missouri's natural gas service areas other than the Rolla Service Area represent an increase of \$0.0600 per Ccf.

**WHEREFORE**, Staff respectfully submits this notice of correction to Staff's recommendation for the Commission's consideration.
