ORDER ESTABLISHING TIME TO FILE RECOMMENDATION

On October 14, 2016, Union Electric Company d/b/a Ameren Missouri issued a tariff adjusting its Purchased Gas Adjustment (PGA) rates. That tariff will become effective on November 1.

Before acting on Ameren Missouri's tariff, the Commission will require a recommendation from its Staff. The Commission will also establish a deadline for any other party that wants to file a recommendation.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation regarding Union Electric Company d/b/a Ameren Missouri's PGA Tariff no later than October 24, 2016.
2. Any other party that wants to file a recommendation regarding Union Electric Company d/b/a Ameren Missouri's PGA tariff shall do so no later than October 24, 2016.

3. This order shall be effective when issued.
