**AMENDED ORDER ESTABLISHING TIME TO FILE
RECOMMENDATION**

On November 1, 2016, The Empire District Gas Company ("EDG") issued a tariff changing its purchased gas adjustment (PGA) rates. The tariff will become effective on November 16, 2016. Before acting on EDG's tariff, the Commission will require an expedited recommendation from its Staff. The Commission will also establish a deadline for any other party that wants to file a recommendation.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation regarding The Empire District Gas Company's PGA tariff no later than 12:00 p.m. noon on November 7, 2016.
2. Any other party that wants to file a recommendation regarding The Empire District Gas Company's PGA tariff shall do so no later than 12:00 p.m. noon on November 7, 2016.

3. This order shall be effective when issued.
