ORDER AMENDING PROCEDURAL SCHEDULE

Issue Date: March 31, 2022

Effective Date: March 31, 2022

Symmetry Energy Solutions, LLC (Symmetry); The Empire District Gas Company d/b/a Liberty (Liberty); the Commission’s Staff; and the Office of the Public Counsel filed a unanimous joint motion on March 31, 2022, asking the Commission to amend the procedural schedule for this case. The motion explains that they have reached a settlement in principle and seek more time to focus on finalizing the settlement. They propose to delay the filing of direct, rebuttal, and cross-rebuttal testimony, while leaving the filing date of surrebuttal testimony and the evidentiary hearing dates unchanged for now. Commission will adopt the amended procedural schedule proposed by the parties.

- Initial Post-Hearing Briefs** - **August 10, 2022**
- Reply Briefs** - **August 17, 2022**
