**JOINT MOTION TO DISMISS**

**COMES NOW** Respondent Spire Missouri Inc. (“Spire Missouri” or “the Company”) and Complainant Mr. Charles A. Harter, by and through counsel, jointly file this motion to dismiss the complaint, stating as follows:

1. On September 13, 2022, Mr. Harter filed a formal complaint against Spire Missouri regarding the cold weather rule payment arrangement between the parties.
2. The Missouri Public Service Commission (“Commission”) ordered Spire Missouri to file an answer on October 13, 2022, and ordered the Staff of the Commission to investigate the complaint and file a report on October 28, 2022.
3. After the filing of the complaint, Mr. Harter and Spire Missouri discussed the complaint, the cold weather rule payment arrangement, and pledges made for the outstanding balance on Mr. Harter’s account. The Parties filed a joint motion to stay the procedural schedule to reach a resolution before Spire Missouri would file its answer. The Commission stayed the procedural schedule until November 14, 2022.
4. On October 5, 2022, the two pledges that were made for the outstanding balance on Mr. Harter’s account were paid.

5. On November 7, 2022, Mr. Harter enrolled in a cold weather rule payment arrangement with Spire Missouri.

6. As Mr. Harter is enrolled in the cold weather rule payment arrangement, which was his requested relief in his complaint, the Parties agree that the complaint should be dismissed.

**WHEREFORE** the Parties respectfully request that the Commission accept this motion to dismiss the complaint and close this docket as the complaint has been resolved.
