MOTION TO ADOPT PROPOSED PROCEDURAL SCHEDULE

COME NOW Summit Natural Gas of Missouri, Inc. (“Summit”) and the Missouri Propane Gas Association (“MPGA”) and for their Motion to adopt Proposed Procedural Schedule state as follows:

1. In its Order Denying Motion for Summary Determination or Dismissal, the Commission set a date of July 2 for the filing of a proposed procedural schedule. On July 2, Summit asked for a one-week extension of that date, which the Commission granted by order issued on July 5.

2. Summit and MPGA have agreed to the following procedural schedule. The Staff of the Public Service Commission and the Office of the Public Counsel have each indicated that they have no objection to this schedule:

September 14	Depositions (to be scheduled by agreement) of MPGA witness held by September 14
October 5	All parties file Rebuttal Testimony
November 9	Depositions (to be scheduled by agreement) of Summit witnesses (and Staff and OPC witnesses, if any) held by November 9

December 7	All parties file Surrebuttal Testimony
December 18	List of Issues; Order of Witnesses, Cross-examination and Opening Statements (to be filed by Summit)
December 21	Statements of Positions
January 15-16	Evidentiary Hearing
February 14	Post-Hearing Initial Briefs
March 7	Post-Hearing Reply Briefs

WHEREFORE, Summit and MPGA respectfully request that the Commission approve this jointly proposed procedural schedule.
