# ORDER EXTENDING TIME TO RESPOND TO AMEREN MISSOURI'S APPLICATION AND STAFF'S RECOMMENDATION

Issue Date: March 31, 2017 Effective Date: March 31, 2017

On December 1, 2016, Union Electric Company d/b/a Ameren Missouri filed an application requesting a modification of its existing variance from the Commission's rule that establishes gas meter testing procedures. The Commission's Staff filed a recommendation regarding that application on March 22, 2017. Staff recommends the Commission approve the application, but would impose certain conditions on that approval. In a response filed on March 30, Ameren Missouri accepted the conditions proposed by Staff.

On March 29, Public Counsel also responded to Staff's recommendation. Public Counsel does not oppose the request for variance at this time, but would like an opportunity to further discuss the matter with Ameren Missouri. It asks to be allowed until April 14 to decide whether it objects to the proposed variance. In its March 30 response, Ameren Missouri said it is willing to hold further discussions with Public Counsel.

The Commission will extend the time to respond to Ameren Missouri's Application and Staff's recommendation.

- Any party wishing to further respond to Ameren Missouri's Application and Staff's Recommendation shall do so no later than April 14, 2017.
