ORDER GRANTING MOTION FOR EXTENSION OF TIME

On September 12, 2022, Roeslein Alternative Energy Services, LLC (RAES), filed an *Application for Waivers*. RAES is requesting a permanent waiver of the requirement under Commission Rule 20 CSR 4240-40.030(3)(I)(3)(B)(I) that sets a design pressure limit of 100 psig for polyethylene pipe with a DF (design factor) of 0.40. RAES is seeking to upgrade the maximum allowable operating pressure to 125 psig for an existing pipeline in Mercer County, Missouri.

On September 13, 2022, the Commission directed the Staff of the Commission (Staff) to file a recommendation regarding the application, or a status report indicating when it expects to file a recommendation, on or before October 13, 2022.

On October 12, 2022, Staff filed a *Status Report*, requesting that the deadline to file a recommendation be extended to November 30, 2022.

The Commission finds the request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Staff's motion for an extension of time to file its recommendation is granted.
2. Staff shall file its recommendation on or before November 30, 2022.
3. This Order shall be effective when issued.
