

**LACLEDE GAS COMPANY'S REPLY  
TO STAFF'S FILING IN COMPLIANCE WITH  
THE COMMISSION'S AUGUST 7, 2003 ORDER**

**COMES NOW** Laclede Gas Company ("Laclede" or "Company"), and files its Reply to the Staff's August 12, 2003 filing in connection with Laclede's Motion to Expedite, and in support thereof, states as follows:

1. In its August 12, 2003 filing, Staff recommends that the Commission extend Laclede's current authorization to sell \$270 million in securities for two months, to October 31, 2003, conditioned upon a restriction that any proceeds from security sales during the extension period be used only for the regulated operations of Laclede Gas Company.

2. Laclede has no objection to Staff's recommended two month extension. Laclede reserves the right to request additional extensions, if necessary, and the right to make any argument it deems advisable regarding the conditions that should ultimately be imposed on future financings following the extension(s).

**WHEREFORE**, Laclede respectfully requests that the Commission grant a two month extension, to October 31, 2003, of Laclede's current authorization to sell \$270 million in securities.
