**KCP&L GREATER MISSOURI OPERATIONS COMPANY'S
MOTION FOR EXPEDITED CONSIDERATION AND APPROVAL OF TARIFF**

COMES NOW KCP&L Greater Missouri Operations Company (“GMO” or the “Company”) and hereby files its Motion for Expedited Consideration and Approval of Tariff Sheets (“Motion”) pursuant to 4 CSR 240-2.080(14). In support of its Motion, GMO states as follows:

1. On August 27, 2018, the Company filed a Limited Large Customer Economic Development Discount Rider tariff to comply with Mo. Rev. Stat. § 393.1640 (2018), assigned Tracking No. JE-2019-0025.

2. On September 25, 2018, Staff (“Staff”) for the Missouri Public Service Commission (“Commission”) filed its *Motion to Suspend Tariff Sheet and Open New Docket*, citing a potential substantive dispute. The Commission issued its *Order Suspending Tariff* that same day.

3. Staff and the Company have been working diligently to resolve the potential substantive dispute and have reached a resolution. The Company filed new tariffs with a 30-day effective date in this docket today. The Company requests that the new tariffs become effective on October 19, 2018 as the Company has received inquiries regarding the availability of the tariff. There will be no negative effect on the Company’s customers or the general public if the Commission grants this Motion.

4. This Motion was filed as soon as it could have been under the circumstances.

WHEREFORE, for the foregoing reasons and for good cause shown, GMO respectfully requests that the Commission grant this Motion, and approve the tariff sheets GMO has filed to be effective for service rendered on and after October 19, 2018.
