1 **Q. PLEASE STATE YOUR NAME AND BUSINESS ADDRESS.**

2 A. Rick H. Lawler, CPA, 7810 Shaffer Parkway, Suite 120, Littleton, CO 80127.

3 **Q. ON WHOSE BEHALF IS YOUR TESTIMONY PRESENTED?**

4 A. I am testifying on behalf of Summit Natural Gas of Missouri, Inc. ("SNG" or the
5 "Company").

6 **Q. BY WHOM AND IN WHAT CAPACITY ARE YOU EMPLOYED?**

7 A. I am the Chief Financial Officer for Summit Utilities, Inc., the parent company of
8 SNG.

9 **Q. HAVE YOU PREVIOUSLY SUBMITTED TESTIMONY AND SCHEDULES IN**
10 **THIS CASE?**

11 A. Yes, I submitted Rebuttal Testimony and schedules on July 11, 2014.

12 **Q. ARE YOU SPONSORING ANY SCHEDULES IN SUPPORT OF YOUR**
13 **SURREBUTTAL TESTIMONY?**

14 A. No.

1 **Q. WHAT IS THE PURPOSE OF YOUR SURREBUTTAL TESTIMONY?**

2 A. The purpose of my Surrebuttal Testimony is to respond to Office of the Public
3 Counsel ("Public Counsel") witness Keri Roth's Rebuttal Testimony as it relates
4 to income tax impacts of the combination of the legacy Southern Missouri
5 Natural Gas assets with the legacy Missouri Gas Utility, Inc. assets that was
6 approved by the Missouri Public Service Commission in its Case No. GM-2011-
7 0354.

8 **Q. WHAT ACCOUNTING TREATMENT DOES MS. ROTH SUGGEST SHOULD**
9 **BE APPLIED TO THE LEGACY SOUTHERN MISSOURI NATURAL GAS**
10 **ASSETS?**

11 A. Ms. Roth suggests that those assets should be booked at a purchase price that
12 is less than the net original cost of the assets.

13 **Q. WAS THE ULTIMATE OWNER OF THE ASSETS (I.E. THE ULTIMATE**
14 **PARENT OF SOUTHERN MISSOURI NATURAL GAS) THE SAME BEFORE**
15 **AND AFTER THE TRANSACTION APPROVED IN CASE NO. GM-2011-**
16 **0354?**

17 A. Yes.

18 **Q. IN HER REBUTTAL TESTIMONY (pages 8-9), PUBLIC COUNSEL WITNESS**
19 **ROTH ALLEGES THAT THE "OWNERS" HAVE BENEFITTED FROM THIS**
20 **TRANSACTION BECAUSE "...APPROXIMATELY 38% OF THE**
21 **DIFFERENCE BETWEEN THE COSTS HAS LIKELY ALREADY BEEN**

1 **RECOVERED BY THE UTILITY[Y'S] OWNERS VIA TAX BENEFITS.” IS**
2 **THIS CONSISTENT WITH YOUR UNDERSTANDING?**

3 A. No. Most importantly, whatever tax benefit or detriment that might have been
4 incurred by SNG's owner has absolutely no impact on SNG's earnings results
5 or financial position and thus, no relevance to the proceedings in this rate case.
6 Nonetheless, in response to Ms. Roth's specific allegation of a 38% tax benefit
7 to SNG's parent relative to its "sale" of utility assets to SNG at less than book
8 value, that presumption is entirely false as the transaction actually resulted in a
9 detrimental monetary impact to SNG's owner's investors due to the pass-
10 through nature of the taxable gain on the sale.

11 **Q. DOES THIS CONCLUDE YOUR SURREBUTTAL TESTIMONY?**

12 A. Yes.
