



Membership shall be restricted to a single representative person per established single residence receiving services in the geographic boundary of the area to be served by the Company, defined as the Carriage Oaks Subdivision (Exhibit A), and as otherwise provided in the Bylaws, consistent with the statutes under which the Corporation is formed. Membership shall not be transferrable. An initial membership fee may be imposed by the directors, refundable without interest in the event membership is terminated, consistent with the statutes under which the Corporation is formed.

9. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

10. This document shall be effective immediately upon filing with the Secretary of State of Missouri.




