**REQUEST FOR EXTENSION OF TIME**

COMES NOW Union Electric Company d/b/a AmerenUE (“AmerenUE” or “Company”), and for its Motion to Amend Verified Petition, states as follows:

1. On May 15, 2009, AmerenUE filed its Verified Petition to Change its Infrastructure System Replacement Surcharge with the Missouri Public Service Commission (“Commission”).
2. On June 12, 2009, the Commission ordered the Staff to file its report regarding its examination of the information no later than July 14, 2009 and also ordered any responses to the Staff report be filed no later than July 24, 2009.
3. On July 14, 2009 the Staff filed its report.
4. Staff personnel who are involved in this case are not currently available for the Company personnel to discuss certain recommendations. Therefore, AmerenUE requests a 1-week extension until July 31, 2009 to respond to the Staff report.
5. Counsel for the Staff has indicated to Counsel for AmerenUE that they are not opposed to this request.
