For March of 2008, planned nominations on the 11671 contract were to be 109,000 dth. (Response to DR#17). Actual nominations were 46,700 dth., of which 15,500 were baseload and 31,200 were swing. Please explain the nominations for the month of March 2008.

For April of 2008, planned nominations on the 11671 contract was to be 112,600 dth. (Response to DR#17). Actual nominations were 106,000 dth., of which 93,000 were baseload and 13,000 were swing. Please explain the nominations for the month of April 2008.

For January of 2008, planned nominations on 11474 contract were to be 26,100 dth. (Response to DR#17). Actual nominations were 30,300 dth., of which 24,500 were baseload and 15,858 was swing. Please explain the nominations for the month of January 2008.

Confidential Response:

Planned nominations are based on 30-year normal weather requirements and will differ from actual nominations due to above/below normal weather conditions, storage positions, and operational considerations. Staff's request pertains to nominations on PEPL for the Hannibal/Canton/Palmyra/Bowling Green system. The following explanations are provided in chronologic order:

Dec07 – Actual nominations were lower than planned nominations because a Haven 400 Line rupture occurred during late Nov07, resulting in the pipeline curtailing nominations during December, which reduced actual nominations.

Jan08 – Actual nominations were higher than planned nominations due to Bowling Green's Dec07 storage level being lower than the planned level. The Bowling Green swing volume was 5,800 not 15,858. The 15,858 swing volume was nominated on EFT 14089 from Field to Market because the Hannibal Propane Air Plant was not in operation and the Company wanted to preserve the highest FS storage ratchet in case peak-day conditions occurred, resulting in higher actual nominations for Hannibal.

Mar08 – Actual nominations were lower than planned nominations because IOS and FS storage levels for Feb08 were higher than planned levels due to preserving the higher ratchet for FS storage during Jan08 and Feb08.

Apr08 – Actual nominations were lower than planned nominations since the IOS storage level for Mar08 was higher than the planned level.
