COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through Staff Counsel, and files in the above-captioned case the following attached documents requested by Commissioner Davis at the October 20, 2010 hearing:

1. Atmos Energy Corporation Cost Allocation Manual (CAM) for 2007
2. Atmos Energy Corporation CAM for 2008, with attached Exhibit "C"
3. Staff's Recommendation for ACA period 2006-2007 review in Case GR-2007-0403. (Please see pages 7 through 9 for Staff discussion of RFP concerns from the '06-'07 review).
4. RFPs and responses for the Hannibal/Canton/Bowling Green service area.

Staff points out the *RFP documents overlap two ACA periods ('06-'07 and '07-'08)* and involve multiple data requests and separate RFPs for the Butler and Hannibal/Bowling Green bids.

Data Request 79 also contained the Hannibal/Bowling Green RFP responses covering the Hannibal RFP period of April '08-March '09

- DR 105 Hannibal/Bowling Green RFP responses for the Hannibal/Bowling Green RFP for April '07 – March '08.

- DR 59 RFP letter for Butler for November '06 – October '07. See pages 22-30.
