1 P R O C E E D I N G S

2 JUDGE LANE: My name is Benjamin Lane. I'm
3 the regulatory law judge assigned to this case, which is
4 Case No. GC-2007-0198, Timothy M. Woodbury versus Laclede
5 Gas Company.

6 By Order dated March 19th, this prehearing
7 conference was scheduled for today, Monday, April 2nd, at
8 2:00 p.m. in Hearing Room 305.

9 Any party who wished to appear by telephone
10 was to notify me by calling me at my phone number which
11 was specified in the Order by no later than March 26th.
12 No such request was received from any party.

13 And, also, any party wishing to file a
14 continuance was also to notify me and indicate why they
15 were unable to appear, give the reason and also specify
16 dates at which they were to appear, and no such requests
17 for a continuance has been received from any party and no
18 request to appear at this proceeding by telephone was
19 received.

20 So before we go any further, I might as
21 well -- I have a pretty good idea, just scanning who is
22 here, and I know from overhearing the conversation before
23 we went on the record who is here, but if each of you
24 would please formally enter your appearance orally.

25 I know you have filed written entries of

1 appearance but just for the record if you would enter your
2 appearances for the record.

3 Let's go ahead and start with you,
4 Mr. Poston.

5 MR. POSTON: Marc Poston appearing on behalf
6 of the Office of the Public Counsel and the public.

7 JUDGE LANE: Thank you.

8 Ms. Heintz and Ms. Kliethermes.

9 MS. KLIETHERMES: Sarah Kliethermes and
10 Jennifer Heintz appearing on behalf of the Staff of the
11 Missouri Public Service Commission.

12 JUDGE LANE: Thank you very much.

13 And Mr. Pendergast.

14 MR. PENDERGAST: Michael C. Pendergast and
15 Rick E. Zucker appearing on behalf of Laclede Gas Company.

16 JUDGE LANE: I will note for the record that
17 Mr. Woodbury is not present, and it is approximately
18 2:09 p.m., or about ten minutes after the scheduled
19 hearing date and time.

20 Normally I would recapitulate what was said
21 in the March 19th Order, particularly for Mr. Woodbury's
22 behalf, as to the purpose of a prehearing conference, what
23 is meant to be achieved. I think everyone here has been
24 to one or more of those.

25 But just very briefly, I want to talk about

1 that, because it may be possible to get something done
2 here, maybe, even without the Complainant to participate,
3 if, in fact, he does not arrive before we conclude the
4 hearing, on-the-record portion of the hearing, and go into
5 the prehearing.

6 Let me first ask each of you that are here,
7 do you see -- given the circumstances of this case, the
8 allegation, pleadings, whether Staff and OPC and Laclede
9 are in agreement or in disagreement as to the proper
10 resolution to this case? Do you see any benefit in
11 continuing with and going ahead and conducting a
12 prehearing conference once I have left given that the
13 Complainant, Mr. Woodbury, is not present?

14 MR. PENDERGAST: Speaking for Laclede,
15 Your Honor, I'd certainly be willing to discuss with the
16 other parties what we'd be willing to offer Mr. Woodbury
17 to get this matter resolved, and I think it might be
18 helpful for me to see if they agree with what my approach
19 would be.

20 That's not to say that Mr. Woodbury will
21 necessarily agree with what we're talking about or what
22 we're proposing, but certainly we're willing to make one
23 more phone call and one more effort to go ahead and try
24 and get the matter resolved, and we certainly would be
25 happy to report back to you, if we can, with any

1 recommendation we might have.

2 JUDGE LANE: Staff, do you have any
3 comments?

4 MS. HEINTZ: That would be agreeable to us.

5 JUDGE LANE: OPC?

6 MS. POSTON: Okay with me.

7 JUDGE LANE: Okay. Very good.

8 I think what we'll do now is, you know, we
9 mentioned the possibility of settlement. I will say that
10 in the Order setting this conference, Mr. Woodbury was
11 notified that failure to appear at this conference without
12 requesting a continuance or without, you know, giving --
13 showing some cause for a failure to appear, may result in
14 the dismissal of either him as a party or on his
15 complaint.

16 And I will say that a show cause order will
17 be issued in which he will be given -- I haven't decided
18 the amount of time, but he will be given some time to show
19 why his complaint should not be dismissed for failure to
20 adhere to the procedural requirements and the Order to
21 attend this conference.

22 Nevertheless, I think I agree with the
23 parties that it might be valuable to just take maybe a few
24 minutes, talk about what Laclede is willing to offer in
25 conjunction with Staff and to get OPC's input as well, as

1 to some extent you can step into Mr. Woodbury's shoes as a
2 representative of the public in this matter. I'm not
3 saying you have to or that would even be appropriate. I'm
4 just saying --

5 MS. POSTON: Okay.

6 JUDGE LANE: -- since he's not here, that
7 might be a possibility.

8 So I don't think there is any need to go
9 into the things that we might otherwise discuss, a
10 procedural schedule, all of those things. Most of that
11 was going to be for Mr. Woodbury's benefit, not being
12 familiar with this type of proceeding.

13 So unless anyone has any other questions or
14 suggestions, I plan to go ahead and go off the record,
15 conclude the on-the-record portion of this proceeding,
16 have you discuss, know that I am available should you need
17 me for anything. You can reach me up in my office or by
18 phone.

19 And, you know, take this time -- since we've
20 got you all here together, take this time and make use of
21 it, and we'll try to find out what happened to
22 Mr. Woodbury this afternoon.

23 All right. Does that sound okay to
24 everyone?

25 MR. PENDERGAST: Thank you, Your Honor.

1 JUDGE LANE: Very good. We're off the
2 record in this proceeding then.
