ORDER GRANTING ADDITIONAL TIME TO FILE AFFILIATE TRANSACTIONS AND MARKETING AFFILIATE TRANSACTIONS ANNUAL REPORTS

Issue Date: December 14, 2017 Effective Date: December 14, 2017

Commission rules 4 CSR 240-40.015(4)(B) and 40.016(5)(B) require regulated gas corporations to file annual reports regarding calendar year affiliate transactions and marketing affiliate transactions by March 15 of the succeeding year. In a 2011 order issued in File No. GE-2011-0171, the Commission granted Spire Missouri, Inc., f/k/a Laclede, a variance from those rules to allow it to maintain its affiliate transaction records on a fiscal-year basis and to file its annual report by December 15 of the succeeding year. On December 14, 2017, Spire Missouri filed an application for variance in which it asks to be allowed until January 15, 2018 to file its annual reports for the last fiscal year.

Spire Missouri explains that it has been unable to prepare the required reports in a timely manner because its employees who are responsible for their preparation have been involved in Spire Missouri's ongoing rate case hearings. Spire Missouri represents that the requested 30-day filing extension will not harm or unduly burden any party.

The Commission finds that the requested extension of time is appropriate and will grant Spire Missouri's request. January 15, 2018 is a holiday, so the reports will be made due on January 16, 2018.

THE COMMISSION ORDERS THAT:

- 1. Spire Missouri, Inc. shall file the annual fiscal year reports required by Commission rule 4 CSR 240-40.015(4)(B) and 40.016(5)(B), otherwise due by December 15, 2017, by January 16, 2018.
 - 2. This order shall be effective when issued.
