In its Motion, Staff stated that it needs additional time to review the supplemental application, and to discuss it with the Pipeline and Hazardous Materials Safety Administration. Thus, Staff asks for an extension of time until September 29, 2023 for Staff to file a Recommendation.

The Commission finds Staff’s request reasonable, and it will grant it.

2. The Staff of the Commission shall file a Recommendation no later than September 29, 2023.
