On February 23, 2017, the Office of the Public Counsel filed a motion asking the Commission to compel Laclede Gas Company to provide certain documents in response to a data request submitted by Public Counsel. On February 24, the Commission ordered that any party wishing to respond to Public Counsel's motion to compel do so by March 2.

On March 1, Laclede filed a motion requesting an additional week to respond to Public Counsel's motion. Laclede explains that it has been discussing the production of the requested documents with Public Counsel and believes that with additional time, an agreement may be reached. The motion represents that Public Counsel agrees that the time for filing a response should be extended.

The Commission will grant Laclede's motion.

THE COMMISSION ORDERS THAT:

1. Laclede Gas Company's Motion to Extend Time to Respond to Motion to Compel is granted.
2. Any party wishing to respond to Public Counsel's Motion to Compel shall do so no later than March 9, 2017.

3. This order shall be effective when issued.
