ORDER GRANTING EXTENSION OF TIME

This case concerns Laclede Gas Company's application for authority to sell a section of natural gas pipeline to an affiliated company, Spire Pipeline, Inc. Enable Mississippi River Transmission LLC (MRT) has been allowed to intervene.

On December 14, 2016, MRT filed a motion seeking an extension of time to object to certain data requests submitted by the Commission's Staff. The motion explains that Staff and MRT have agreed that responses to those data requests are due by January 17, 2017. MRT's motion asks that it be allowed until January 6 to make any objection to those Staff data requests. On December 16, Staff filed a response, indicating it does not object to MRT's motion.

The Commission finds MRT's motion to be reasonable, and unopposed. The Commission will grant that motion.

THE COMMISSION ORDERS THAT:

1. The Motion for Extension of Time of Enable Mississippi River Transmission, LLC is granted.

2. Enable Mississippi River Transmission, LLC is allowed until January 6, 2017 to object to data requests submitted by Staff on December 6, 2016.

3. This order shall be effective when issued.
