This case concerns Laclede Gas Company's application for authority to sell a section of natural gas pipeline to an affiliated company, Spire Pipeline, Inc. Enable Mississippi River Transmission, LLC (MRT) has been allowed to intervene.

The Commission previously ordered its Staff to file a status report, recommendation, or proposed procedural schedule by January 10, 2017. On January 6, Staff filed a status report indicating it has continued to work with the parties and needs more time to consider the application. Staff asks that it be allowed until March 10 to file a status report, recommendation, or proposed procedural schedule. On January 17, Laclede filed a response indicating it concurs with Staff's request for more time. No other party has filed a response.

The Commission will grant Staff's request for more time.

THE COMMISSION ORDERS THAT:

1. No later than March 10, 2017, Staff shall file a status report, a recommendation, or a proposed procedural schedule.

2. This order shall be effective when issued.
