**STIPULATED MOTION FOR EXTENSION OF TIME TO RESPOND
TO MOTION FOR SUMMARY DISPOSITION**

COMES NOW Respondent Carl Richard Mills, by and through counsel, and respectfully requests an extension of the deadline to respond to Complainant’s motion for summary disposition and states as follows in support:

1. On November 30, 2021, Respondent filed an Application to Transfer the water system at issue in this complaint matter to Carriage Oaks Estate Water and Sewer Not-For-Profit.
