## ORDER APPROVING COMPLIANCE TARIFF

Issue Date: August 23, 2010 Effective Date: September 1, 2010 The Missouri Public Service Commission is approving the tariff sheets ("compliance tariff") that Laclede Gas Company filed<sup>1</sup> as ordered<sup>2</sup> in the *Report and Order*.<sup>3</sup> A tariff filed with the Commission may become effective without a hearing or any other procedure.<sup>4</sup> Nevertheless, the Commission directed Staff to file a recommendation as to whether the compliance tariff conforms to the *Report and Order*.<sup>5</sup>

On August 23, 2010, Staff filed its recommendation, with a supporting affidavit, favoring approval of the compliance tariff to be effective on September 1, 2010, and stating that it conforms to the *Report and Order*. The *Report and Order* incorporated the terms of the *Second Stipulation and Agreement*,<sup>6</sup> which was unanimous, included specimen tariff sheets, and provided for approval of a compliance tariff effective on September 1, 2010.

Such facts constitute good cause to dispense with responses to the recommendation<sup>7</sup> and

make the compliance tariff effective less than 30 days after filing.<sup>8</sup>

Therefore, the Commission will approve the compliance tariff.
