**ORDER APPROVING TARIFF  
FOR LOW INCOME ASSISTANCE PROGRAM**

Issue Date: November 23, 2010

Effective Date: November 26, 2010

The Missouri Public Service Commission is granting the *Motion To Approve Tariff Filing On Less Than Thirty Days' Notice and Motion For Expedited Treatment* ("the motion") and approving the accompanying tariff sheet ("the tariff"). Laclede Gas Company ("Laclede") filed the motion and the tariff.<sup>1</sup> A tariff filed with the Commission may become effective in less than thirty days from its filing date for good cause<sup>2</sup> without a hearing or any other procedure.<sup>3</sup>

The motion and tariff address a matter deferred in the *Report and Order*.<sup>4</sup> modifications to Laclede's low-income assistance program ("program"). In the motion, Laclede represents that the tariff:

- adjusts the program but retains current customer program benefits,

- is the result of discussions with stakeholders in Laclede's service territory,
- has the support of Staff and the Office of Public Counsel, and
- is filed as soon as possible after the parties' agreement.

Laclede also states that no party objects to the motion and tariff, and no party filed a response to the motion and tariff within the time prescribed by order.<sup>5</sup>

Such facts constitute good cause to approve the tariff, and to make the tariff effective in less than 30 days after filing.<sup>6</sup>

**THE COMMISSION ORDERS THAT:**

1. The tariff sheet to which the Commission assigned Tracking No. YG-2011-0246 is approved to become effective on November 26, 2010. The specific tariff sheets approved are:
